Subject: Fee Details for the academic year 2026-27

Dear Parent,

We deeply value your continued association with the school and sincerely appreciate your trust and support in us.

The New Fee Regulation of 2025, mired with controversies and ambiguity, is a subject matter of challenge by many Private Recognised Unaided Schools Associations, before the Hon'ble Delhi High Court.

Vide interim directions of the Hon'ble High Court of Delhi on the constitutional validity of the said legislation, deferred the constitution of committees under the said legislation, and also directed that the Private Recognised Unaided Schools shall continue to charge fees as charged by the Schools for the academic session 2025-26, until further orders of the Hon'ble Court.

Accordingly, the fee structure to be followed till further intimation from the school, for the academic session 2026-27, is given below. The same has been notified on the school website.

Note for New Admissions: *The advance fee paid at the time of admission, which was prior to the Hon'ble High Court orders, is being adjusted against the total fee for the first three months (April, May and June 2026). The balance amount has been adjusted against the tuition fee for the month of July 2026. Accordingly, no fee is payable for the months of April, May and June 2026, and a reduced fee shall be payable for July 2026. From August 2026 onwards, the regular monthly fee of Rs. 13,665/- shall be payable. Transport charges, if applicable, are payable separately and have not been adjusted against the advance fee.*

To ensure a seamless and convenient payment experience, kindly remit the monthly fees online using the Parent App or through the secure payment link provided on our school website. The fee bill for April 2026 will be available on the Parent App starting from 03 April 2026. The payment for April 2026 is due by 15 April 2026. As per school rules, School fees & notified charges should be paid in advance, by the 10th of each month. Late fee of Rs. 250/- will be levied if the payment is made between 11th and 20th of the month, and thereafter, Rs. 750/- will be levied.

Needless to state, this is subject to the final orders of the Hon'ble High Court, as may be passed in the aforesaid pending cases. Further adjustments, if any, shall be duly notified. The school shall notify parents immediately upon the Hon'ble Court pronouncing its final decision in the matter. The school reserves the right to recover the differential fee for the period commencing April 2026, depending upon further orders / directions of the Hon'ble High Court of Delhi. In case of any clarification, you are at liberty to contact the school authorities.

We would like to take this opportunity to thank you once again for your trust in our institution. We look forward to working together to make the academic year 2026-27 a truly enriching and transformative experience for all our students.
