Learning becomes more meaningful when children experience it beyond the classroom. With this objective, the school is organizing an **Educational Excursion to Oh! Max Dreamworld, Greater Noida** for the students of **Classes III to V** on **Saturday, 18th July 2026**.

The visit has been planned to provide students with an engaging blend of learning and recreation. Programme Details

- **Reporting Time at School:** 8:00 a.m.
- **Expected Arrival Back at School:** 3:30 p.m.
- **Mode of Transport:** School Buses
- **Excursion Charges:** ₹1000/- per student (inclusive of entry fee, breakfast, and lunch, transport)

Dress Code

Students must report in **complete school uniform**.

- **Boys:** Regular school uniform, along with sports shoes for comfort and ease of movement.
- **Girls:** School uniform (Girls wearing skirts are advised to wear full-length school stockings/leggings underneath for comfort and ease of movement. If required, school trousers may be worn as an alternative.)

Students must carry their **School Identity Card**, which is **mandatory** for participation.

Safety Arrangements

The safety and well-being of our students remain our highest priority.

- Students will travel in school buses under the supervision of teachers.
- Adequate teacher supervision will be maintained throughout the excursion.
- The school will take every possible precaution to ensure the safety, security, and comfort of all students during the visit.

Important Instructions

1. Breakfast and lunch will be provided during the excursion.
2. Students should carry a labelled water bottle.
3. Students should avoid carrying mobile phones, valuables, electronic gadgets, or expensive accessories.
4. Students are expected to maintain discipline and follow all instructions given by the teachers throughout the excursion.
5. School buses will operate as usual in the morning. However, **parents are requested to pick up their ward from the school at 3:30 p.m.** No school bus service will be available after the excursion.
6. **The excursion fee is non-refundable once paid, as advance bookings and arrangements are made individually for each participating student.**
7. The last date for submission of the excursion fee and the duly signed consent form is **Sunday, 12th July 2026.** Parents are requested to make the payment through the **ERP portal** well in advance and submit the duly signed consent form to the class teacher by the due date. **Please note that no student will be allowed to participate in the excursion unless both the payment is successfully made through the ERP and the signed consent form is submitted to the class teacher.**
